Approve Agenda: Motion by Scalzo, second by Wallace, to approve the agenda as presented. Motion Carried

Clerk's Report: Clerk Kessler reported on the February primary election turnout, the fire dues report has been completed, the annual injury report has been completed and the annual cigarette and tobacco report has been completed. Storage Building Furnace: Two bids were received. Town and County Heating for a 75,000 BTU unit for \$2,580. Noah Skluzacek for a 125,000 BTU unit for \$3,080. Motion by Scalzo, second by Wallace, to have the Chair reach out to both for quotes on the same size and purchase the one most advantageous to the town. Motion Carried

Website: Clerk Kessler reported that the company who designed our website and maintains our domain is retiring. They have given us a name of another company, North of Eight Design and they can rebuild it as is for \$1,000 and then will host it and maintain our domain as Magnifisites has in the past. Motion by Scalzo, second by Wallace, to approve having North of Eight Design complete our website work. Motion Carried

Correspondence: Clerk Kessler reported that the County will pay for up to \$3,000 for clean-up day(s).

Citizens Comments: Steve Esser asked about the minimum lot size to sell and about the wood along-side the roads that have been cleared.
